Program Requirements

These program requirements were created to provide consistent and high-quality training for our customers. All partners must adhere to these requirements to participate in the program.

General Program Requirements

- Authorized Training Partners and instructors must use PMI-developed course content when teaching PMI courses.
- Instructors must complete and pass the appropriate Train the Trainer session for the course they are teaching.
- Instructors must be certified in the certification they are teaching and be in good standing with PMI.
- Authorized Training Partners must be able to provide in-person and/or virtual instructor-led courses.
- Authorized Training Partners and instructors must adhere to all PMI brand guidelines and policies.
- Authorized Training Partners must have a documented issue-resolution process for customers.
- Organizations must be a legal business entity for 1-3 years and have 1-3 years of training experience, depending on tier.
- Authorized Training Partners must pass the ATP application review process.
- Authorized Training Partners must agree to upload “guaranteed to run” public courses.

If you deliver PDU-only training or training for PMI certifications that are not available as an instructor-led training for Authorized Training Partners:

- You are not required to use PMI-provided content.
- Instructors are not required to complete the Train the Trainer course.
- Instructors do not need agile experience.

Program Restrictions

PMI Authorized Training Partners may NOT deliver on-demand, self-paced PMP® exam prep or any alternate PMP exam prep offering (e.g., books). PMI has developed a self-paced PMP exam prep offering. This allows us to address the needs of modern-day learners and ensure consistent, high-quality exam prep experiences for both instructor-led and on-demand modalities. However, at this time you may provide on-demand, self-paced content for other PMI certifications and trainings, except for PMI-CP™, PMI-ACP®, and Disciplined Agile®.

PMI® Authorized Training Partner Program Licensed Course Content

Authorized Training Partners that deliver courses that are available as a PMI Authorized Instructor-Led Training (including PMP®, CAPM®, PMI-ACP®, PMI-CP™, PMI-RMP®, PMI-PMOCP™, and Disciplined Agile® courses) are required to use PMI-licensed course content and must purchase student materials for each individual enrolled. This ensures a consistent, high-quality learning experience and provides the PMI-approved content customers asked for—and the comprehensive knowledge needed to prepare for these exams.


Augmenting the Content

You may supplement the content with your own case studies, learning activities and industry-specific training information, as long as the provided materials are not altered.

PMI Authorized Training Partner Train the Trainer

Authorized Training Partners that deliver PMI instructor-led courses must complete the corresponding Authorized Training Partner Train the Trainer program. This ensures our candidates are being taught by qualified instructors who understand the content and can meet their needs as modern-day learners.

Training Session Options

To accommodate our global network of instructors, we offer virtual instructor training. Program participants receive complimentary credits for these sessions. Please refer to section 2 for information about quantities and purchasing additional credits.

Instructors must complete the Authorized Training Partner Train the Trainer prior to offering any courses. Once completed, instructors will receive an Authorized Training Partner Instructor badge to show that they are approved by PMI. Authorized Training Partners with a badged instructor will be able to order the PMI Licensed Course Content for the appropriate course.

Instructors must demonstrate that they meet the certification requirements for the course and submit a professional bio for review and approval when registering for the Train the Trainer session.
